AGREEMENT TO APPEAR AND OBEY CONDITIONS (If Applicable)

An Order having been made by the above entitled court releasing me on my own recognizance, I hereby agree:

1. That I will appear at all times and places as ordered by any court or magistrate. That I will not depart this State without leave of the Court. That if I fail to appear and am apprehended outside the State of California, I hereby waive extradition. I understand that any court of competent jurisdiction may revoke this order of release and either return me to custody or require that I give bail or other assurance for my appearance. I further understand that if I fail to appear when required to do so by the Court I may be charged with an additional crime, to wit:

MISDEMEANOR, violation of Section 1320(a) PC.
I further understand that punishment following conviction is imprisonment in the county jail not exceeding six months, or by fine not exceeding One Thousand Dollars (\$1000) or by both.

FELONY, violation of Section 1320(b) PC. I further understand that punishment following conviction is by fine not exceeding Five Thousand Dollars (\$5000), or imprisonment in state prison, or in the county jail for not more than one year, or by both such fine and imprisonment.

- Do not possess any weapons or ammunition
- Have no contact including personal, electronic, telephonic, or written contact with _____
