OAKLAND, CALIFORNIA: Superior Court of Alameda County repeals emergency Local Rules and forms; adopts new and amended Local Rules and forms, along with new Bail Schedule; and launches new web site.

The Superior Court of Alameda County (Court) announced today that it has repealed a number of emergency Local Rules and forms that were adopted during the pandemic and has adopted a number of new and amended Local Rules and Forms, along with a new Bail Schedule. These changes, detailed below, were made pursuant to the authority conferred by Chief Justice Tani Cantil-Sakauye in her March 23, 2020, Statewide Order and in light of the upcoming April 30, 2022, rescission of that Order and June 30, 2022, sunset of the Judicial Council of California's remaining Emergency Rules.

Effective April 30, 2022, the Court will repeal the following:

- Emergency Local Rules <u>1.2a</u>, <u>1.7a</u>, <u>1.8a</u>, <u>3.29</u>, <u>4.115</u>, <u>4.116</u>, <u>5.32</u>, <u>5.38</u>, <u>5.46</u>, <u>5.66</u>, <u>7.180</u>, and <u>7.825</u>; and
- Forms <u>ALA-FL-EMER-060</u> and <u>ALA-CRM-EMER-001</u>.

Effective May 27, 2022, the Court will also repeal form <u>ALA-CRM-014-A</u>.

Effective April 30, 2022, the Court will adopt the following:

- Amendments to Local Rules <u>1.7</u> and <u>1.90</u>;
- New Local Rule <u>1.8.1;</u>
- Amendments to form <u>ALA-CRM-014</u>;
- New local form <u>ALA-CRM-019</u>; and
- The <u>2022 Misdemeanor and Felony Bail Schedule</u>.

The Court is also pleased to announce that, with the assistance of staff from its Office of Information Technology and the Judicial Council of California, it has updated its <u>web site</u>. The new site has been redesigned to be easier to use and navigate.
